1. Application submission period for admission in University Departments/Institutes under Ranchi University - 01.12.2020 to 10.12.2020
2. Provisional professional selection list to be published by HoD/Director of Institute - 12.12.2020
3. Period of admission for selection list - 14.12.2020 to 21.12.2020
4. Session begins subject to COVID-19 guidelines - 21.12.2020

NB: - Admission may continue further if the seat remains vacant even after beginning of the session.

The original Certificates will be verified at the time of admission. If an applicant fails to produce the original certificate then his/her Claim will be rejected.




